LOCAL OFFICIALS OF KENTUCKY COMMISSIONED BY GOVERNOR JAMES GARRARD, 1801-1804

This listing of early local officials of Kentucky was compiled from entries in the Executive Journal of Governor James Garrard and encompasses those commissions dated January 1801-August 1804. For the presentation, names of the officials have been extracted from the original record, on microfilm, and have been alphabetically arranged by county. Given with each official's name is the "office" for which he received the commission, the commission date (month [numerical] / year), and any notations. These offices are abbreviated as: JP (Justice of the Peace); JCQS (Justice of the Court of Quarterly Sessions); Shff (Sheriff); Inspr (Inspector of Warehouse [tobacco, hemp, flour]); Crnr (Coroner); Srvyr (Surveyor); NP (Notary Public); ACJ (Assistant Judge of the Circuit Court), etc. Previous compilations of local officials of Kentucky commissioned by the Governors, 1792-1800, were presented in Kentucky Ancestors 28-3, 28-4, and 29-1.
