ARTICLES OF INCORPORATION OF AUGUSTA LIBERTY BANK,
OF AUGUSTA, BRACKEN COUNTY, KENTUCKY.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned and named persons have associated themselves together and have become an incorporated company in accordance with the laws of the State of Kentucky, with the following provisions, to wit:

FIRST. The name of the corporation shall be the
AUGUSTA LIBERTY BANK.

SECOND. The principal office and place of business of said corporation shall be AUGUSTA, BRACKEN COUNTY, KENTUCKY.

THIRD. The nature of the business proposed to be transacted, shall be to operate, conduct and carry on a general banking and finance business, and the object or purposes proposed to be transacted, promoted and carried on shall be

A. Exercising all the rights and privileges granted in Chapter 52 of the Kentucky Statutes and all amendments thereto and shall do a general banking business, including the right and privilege of discounting and negotiating, notes, drafts, bills of exchange and other evidence of indebtedness; to purchase bonds, receive deposits and allow interest thereon, buy and sell securities, exchange, coin, bullion and lend money on personal and real security and to secure and own by purchase or lease a proper building and fire and burglar proof vaults and safe deposit boxes to be loaned or rented to its customers, and do all and everything shown, done, proven and exercised by banks under the laws of Kentucky, and enjoy and exercise all rights and privileges conferred by law on such corporations.

FOURTH. The amount of the capital stock authorized is

TWENTY FIVE THOUSAND DOLLARS

divided into 500 shares of the par value of Fifty dollars
